Heard finally with the consent of both the counsel.

2. By invoking provisions under Section 19 of the Administrative Tribunal Act, applicants have questioned the selection process and sought appointment on the post of District Malaria Officer at Nagpur.

3. In response to the advertisement dated 15.03.2023, the applicants have applied for the said post at Nagpur District in the category of नियमित क्षेत्र कर्मचारी (इतर उमेदवारांमधून ५० टक्के) for which 14 posts

were reserved. It is applicants' case that they have cleared the necessary examination and stood in the merit reflecting their names in provisional select list. It is applicants' contention that though initially 14 posts have been advertised for said category, however, during mid-process the respondents have reduced the posts from 14 to 6 posts only. In consequence, one post in S.T. Category, one post in O.B.C. Category, one post in E.W.S. and three posts in Open Category remained. The reduction of posts made applicants ineligible. The main grievance is that once the posts are advertised, candidates applied and stood in merit, then the posts cannot be reduced.

4. In response, the respondents have filed affidavit-in-reply stating that Clause No. 1.1 of the advertisement makes it abundant clear that there is possibility of increase or decrease in the number of posts After advertisement, reduction advertised. may occur due to interdivisional transfer, compassionate appointment or for like reasons. It is contended that in said category six posts are already filled due to compassionate appointment, whilst two posts are filled due to reversions of two employees to their original posts. In the result, those eight posts have been reduced. In consequence, the posts advertised have been reduced to the extent of six posts. Though, it is submitted by applicants that once the posts were advertised, candidates have applied and appeared for examination, the posts cannot be changed, however, due to variety of reasons, change occur. The advertisement itself is very clear on said aspect.

5. According to applicants, excess posts were filled on compassionate basis but we do not see any substance in the said contention, since total posts were 277 and filling up these posts would be less than 20% of vacancies. One another submission is that there is no clear reply from State whether one handicap post was filled from the handicap category while making compassionate appointment. Likewise, reservation bifurcation has not been given. We do not expect such bifurcation in the reply, since there is no clear pleading so as to expect response from the other side. The applicants have no right to claim appointment. It is apparent that due to change in circumstances, the posts have been decreased for valid reason. In conclusion, Original application carries no merits, hence dismissed with no order as to costs.
