#### JUDGEMENT

Heard D.S. Sawarkar, learned counsel for the applicants and Shri A.P. Potnis, learned P.O. for the respondents.

2. The applicants have been appointed the on establishment of Commandant SRPF GR-13 at Gadchiroli District in recruitment process held in the year 2014. The applicants have joined on different dates. It is applicants' contention that seniority list prepared on 01.01.2023 is erroneous since it was prepared as per merit and not as per date of joining. The applicants are not sure whether seniority list was prepared prior to year 2024. The applicants have attracted out attention to the Maharashtra Civil Services (Regularization of Seniority) Rules 1982, to contain that the seniority ought to have been fixed as per date of joining. In this regard, they have attracted our attention to Rule 5 of the Rule 1982.

3. The State resisted the contention by submitting that seniority list was rightly prepared in consonance with prevailing rules. In particular it is stated that as per rule 4 (2) (a) of the Rules of 1982, if the person is appointed directly in the same batch, then seniority shall be as per determination of selection board.

4. We have gone through Rule 4(2) of the Rule 1982 which reads as below.

2) Notwithstanding anything contained in sub-rule (1),-

(a) the inter se seniority of direct recruits selected in one batch for appointment to any post, cadre or service, shall be deter-mined according to their ranks in the order of preference arranged by the Commission, Selection Board or in the case of recruitment by nomination directly made by the competent authority, the said authority, as the case may be, if the appointment is taken up by the person recruited within thirty days from the date of issue of the order of appointment or within such extended period as the competent authority may in its discretion allow;

5. Rule 4 pertains to general principal of Seniority. Sub clause (a) of clause 2 postulates as to how seniority of direct recruits selected in one batch shall be maintained. It is specified that such seniority shall be determine according to their marks in order of preference arrange by the commission and/ or selection board provided, they have been join within stipulated period or extended period. The rule is crystal clear stating about fixing of seniority as per merit. The applicants have relied on Sub clause 2 of the Rule 5 which pertain to assignment of deemed date of appointment. In the matter in hand there is no question of deemed date as all the applicants have join in the year 2014 in the same recruitment process. Thus, the contention raised by the applicants that the seniority shall be as per date of joining is not acceptable. Though the applicant placed reliance on the decision of the Hon'ble Supreme Court in Case of <u>S.D.K.PURI VS. R.S.</u> <u>BHATIA & ANO. IN CIVIL APPEAL NO. 188/1983</u> it has no bearing on the issue involved since we are dealing the case of direct recruits by following recruitment process. In view of above the application carries no merit hence **dismissed**.
