**2.** The case of the applicant in short is as under:-

Applicant applied for inter district transfer. The said application was rejected by the respondent No.2 – Commissioner of Police as per order dated 24/01/2024. Therefore, applicant has filed the present O.A. for direction to the respondent to reconsider the order dated 24/01/2024 and give the posting to applicant as prayed in the representation.

- 3. O.A. is strongly opposed by the respondents. It is submitted that there is no cause to file the present Original Application. The representation filed by the applicant is already rejected by the Commissioner of Police i.e. Respondent No.2. Hence, the O.A is liable to be dismissed.
- 4. Learned counsel for applicant has submitted that applicant will file fresh application and the respondents be directed to consider the same. Learned P.O. has strongly objected

to the prayer made by the applicant. Hence, in view of above
