Heard Shri R.L.Khapre, learned Senior Counsel for the applicants Shri S.A.Deo, learned C.P.O. for the respondents 1 & 2, Shri P.R.Puri, ld. Counsel for the respondent no.3 and Shri Nitin Lambat, learned counsel for the respondent no.4.

- 2. The applicants have filed this O.A. dated 20.03.2025 challenging the G.R. dated 11.02.2025 and Circular dated 10.02.2025 issued by authorities from the Higher and Technical Education Department based on the new guidelines issued by All India Council for Technical Education (A.I.C.T.E.) in the Approval Process handbook for the years 2024-2027. The applicants have prayed for following reliefs-
 - 1. Quash and set aside Government Resolution dated 11/02/2025 at Annexure-A-10 and order passed by Respondent no.2 dated 10/02/2025 at Annexure-A-11 and further be pleased to direct respondents to re-calculate strength of teachers in accordance with percentage of period of curriculum given in Annexure-A-4 i.e. 78% for Engineering subjects and 22% for Science and Humanities and allocate sufficient number of staff for Science and Humanities after re-calculating the staff by setting aside staff approval approved by Government in its order dated 11/02/2025 after taking into consideration actual number of students as available for all colleges

under all quotas i.e. Economically Weaker Section (EWS), Tuition Fee
Waiver Scheme (TFWS) and laterally entered to second year.

- 2. During the pendency of Original Application, effect, operation and implementation of Government Resolution dated 11/02/2025 at Annexure-A-10 and order passed by Respondent no.2 dated 10/02/2025 at Annexure-A-11 may kindly be stayed by directing respondents not to implement same till decision of Original Application.
- 3. The facts of the case as mentioned in this O.A. are as follows-

The applicants are working as permanent Lecturers in Government Polytechnic Colleges at various places throughout the State of Maharashtra.

- 4. The A.I.C.T.E. has issued the Approval Process Handbook 2024-2027 and the State Government has issued the G.R. and a Circular as mentioned in the prayer, based on the relevant guidelines of AICTE. The applicants feel that the G.R. and Circular are not as per the A.I.C.T.E. Guidelines. Therefore, they have filed this Original Application challenging the above said G.R. and Circular. The relevant portion of the application is as follows-
 - 7.8 That in fact even before introduction of faculty student ratio as 1:20 less number of lecturers were employed in all these faculties and there were vacancies for these subjects. However, thereafter on

the basis of increase of student faculty ratio from 20 to 25, State Government has issued a Government Resolution dated 11/02/2025 in which Science and Humanities Department faculty are reduced by almost 50 percentage of earlier sanctioned posts which were already short of actual requirement, copy thereof is enclosed herewith as Annexure-A-10, which is impugned in present Original Application. It is submitted that on the basis of informal communication of approval by Government of proposed Government Resolution which is in offing, Respondent no.3 in undue haste took up said ratio as approved by State Government i.e. faculty student ratio as 1:25 and issued order dated 10/02/2025, copy thereof is enclosed herewith as Annexure-A-11 and said order passed by Respondent no.3 is also subject matter of present Original Application. It is submitted that as per Annexure-A-10 now posts sanctioned without taking into consideration actual strength of students taking education in all these colleges and for purposes of calculation of posts in Government Resolution dated 11/02/2025, intake is considered as shown in table enclosed herewith as Annexure-A-12. The actual calculation of teacher student ratio and actual students who are taking education in all these colleges are around 62910. As against it, Government has considered only intake capacity 51336 and thus failed to calculate teacher student ratio by calculating around 11564 students less than actually taking education in all these colleges. It is submitted that in order to show that no rational is applied for calculating number of posts of lecturers in various colleges, applicants are herewith

showing discrimination as can be seen from intake capacity of students in Electrical Engineering program in Government Polytechnic Amravati is 60 and the sanctioned posts for the same is 8 and as against it though intake capacity of students for Electrical Engineering program in Government Polytechnic, Murtizapur is same, number of posts of lecturers are shown to be only six, copy of said table showing disproportionate sanction is enclosed herewith as Annexure-A-13.

- 7.9 It can thus be seen that entire sanction of posts as done by Government in accordance with Government Resolution at Annexure-A-10 supra is thus irrational and arbitrary.
- 7.13 That if Government Resolution dated 11/02/2025 at Annexure-A-10 is seen, it specifically states that existing lecturer will have to take tutorials which will not be counted in their workload and they will not be paid any extra amount for same, which is thus contrary to the fixation of workload as done by Government Resolution dated 11/09/2019 at Annexure-A-16 so also it violates Handbook for Distribution of workload in accordance with curriculum as fixed by Respondents no.3 & 4 and thus it is apparent that order at Annexure-A-11 passed by Respondent no.3 is totally bad in law.
- 5. The Respondent no. 1 and 2 have submitted their reply on 04.04.2025. The respondents have stated that they have followed the A.I.C.T.E. Guidelines in issuing the G.R. and Circular and therefore

there is no merit in the prayers made by the applicants. The relevant portion of the reply is as follows-

- 8. So far as the point involved in the instant original application is concerned, it is in respect of restructuring of staffing pattern made by the answering respondents. On the basis of the norms laid down by the AICTE i.e. Respondent No.4, it is already stated that, the decision in respect of Staffing Pattern as well as the intake capacity of the students in respect of per stream, per college has been taken into account by the AICTE. Earlier the ratio of per teacher against the number of students was decided by the AICTE as 1(one) teacher for every 20 (twenty) students i.e. 1:20. However, the AICTE, thereafter, changed the aforesaid percentage and now the AICTE has issued the Notification thereby restructuring the percentage of 1 (one) Teacher for 25 (twenty five) Students instead of 20 (twenty) Students i.e. 1:25.
- 22. The contention of the applicants so far as the calculation of approved intake is concerned, the same is categorically denied. In fact it is submitted that, as per the AICTE Approval Process Handbook 2024-2027 the definition of approved intake is as follows:

"The maximum number of students that can be admitted in a course (excluding the Supernumerary Seats) as approved by the Council".

Now we have to find out the approved intake in consonance with the aforesaid definition given by the AICTE. For calculation of

staffing pattern as per the faculty to student ratio is 1:25, the approved sanctioned intake with lateral entry (10% of intake) of students is considered and as contended by the applicants that the Tuition Fee Waiver Seats i.e. TFWS and Economically Weaker Seats i.e. EWS as per Approval Process Handbook to be considered as of supernumerary nature which cannot be included for calculation of Staffing Pattern.

- 45. A bare perusal of the chart prepared by the Applicants would reveal that the Applicants have included subject wise workload that too by including the candidates of EWS and TFWS categories. As it is already submitted that the candidates of EWS and TFWS cannot be taken into consideration while calculating the approved intake as per the AICTE approval process. Hence, once again it is submitted that there is no basis in the said contention raised by the Applicants.
- 6. The main prayer of the applicants is to quash and set aside the G.R. dated 11.02.2025 and Circular dated 10.02.2025. We shall first discuss the issues related to the G.R. dated 11.02.2025. The G.R. dated 11.02.2025 is about sanctioning the revised Staffing Pattern of staff in the Government Engineering and Pharmaceutical Science. The Government has approved revised Staffing Pattern based on the new criteria's declared by A.I.C.T.E. Approval Process Handbook 2024-2027. As per the Annexure A-5 of this Handbook, the Diploma/Post Graduation Certificate Programme the

Faculty/Student ratio based on the approved intake is given as 1:25. This Annexure mentions the revised ratios for some other cadres also. As per the applicants, the three categories of students, namely Economically Weaker Section (EWS), Tuition Fee Waiver Scheme (TFWS) and those laterally entered to second year are to be counted as part of the approved intake capacity and not as supernumerary students. The A.I.C.T.E. is the authority to issue guidelines and norms for various Diploma and Degree courses. The State Government has issued the impugned G.R. to implement the revised guidelines. Therefore, it needs to be seen whether these G.Rs. are in agreement with the guidelines or there is any discrepancy between the two. The terms approved intake and supernumerary seats have been defined by A.I.C.T.E. as follows-

"Approved Intake" means the maximum number of students that can be admitted in a Course (excluding the Supernumerary Seats) as approved by the Council.

"Supernumerary seats" means Intake over and above the "Approved Intake" which includes TFW, OCI / Foreign Nationals/ Children of Indian Workers in the Gulf Countries, **Lateral Entry**, PwBD, Kashmiri Migrants and PM-USPY seats notified from time to time and for working professionals.

7. The respondents have stated in their reply that they accept that, for calculation of the Staffing Pattern as per the faculty to student ratio 1:25, the later entry (10% of intake) students are counted in the approved intake. However, they have stated that the EWS seats and TFWS seats are of supernumerary nature and cannot be included in approved intake for calculation of Staffing Pattern requirements. So, we shall first discuss the status of these two categories in view of the A.I.C.T.E. guidelines. We shall again discuss all the three categories in paragraph 11. We have already mentioned the definition given by A.I.C.T.E. about the approved intake and supernumerary seats. These two categories have been further described in detail in the guidelines given in Approval Process handbook for the years 2024-2027. The Section 6.37 discusses the EWS category, the Section is as given below-

6.37 The State, Government/UT/Directorate of Technical Education/ Directorate of Medical Education shall ensure that 10% of reservation for Economically Weaker Section (EWS) as per the reservation policy for admission, operational from the Academic year 2019-20 without affecting the reservation percentages of SC/ST/OBC/ General. However, this would not be applicable in the case of Minority Institutions referred to the Clause (1) of Article 30 of Constitution of India. Further, the implementation of 10% EWS reservation in the private unaided-Institutions may be considered

based on the relevant policies of the respective state governments.

The intake in these Institutions shall be 1,25 times of the existing intake of respective categories in these institutions.

NOTE: EWS vacant seats shall be considered for the Lateral Entry to Second Year Course(s) with the same reservation policy for admission.

- 8. The Section 6.42 is about Tuition Fee Waiver Scheme.
 Clause 'd-i' of this Section is as follows
 - d. Admission Procedure.
 - i. Under this Scheme, up to a maximum of 5% of "Approved Intake" per Course shall be available for this admission. These seats shall be supernumerary in nature. These supernumerary seats shall be available only to such Course(s) in an Institution, where a minimum of 50% of "Approved Intake" are filled up in the last Academic year.
- 9. It is clear from these two Sections and definitions of the supernumerary seats that the category of TFWS is treated as supernumerary whereas there is no mention that the EWS is to be treated as supernumerary in the A.I.C.T.E. guidelines. The A.I.C.T.E., which is Respondent No.4, was specifically asked to file a clarification in this regard. The Respondent No.4 has filed a pursis on 21.04.2025. They have referred to an Office Memorandum dated 17.01.2019 by

the Ministry of Human Resource Development, Department of Higher Education, New Delhi. The relevant portion is as follows:

As per the said Office Memorandum, Clause 2(c) specifically stipulate that

"Every Central Educational Institution shall, with the prior approval of the appropriate authority (as defined in clause (c) of Section 2 of The Central Educational Institutions (Reservation in Admission) Act, 2006), increase the number of seats over and above its annual permitted strength in each branch of study or faculty so that the number of seats available, excluding those reserved for the persons belonging to the EWSs, is not less than the number of such seats available, in each category, for the academic session immediately preceding the date of the coming into force of this O.M."

Thus, the seat reserved for Economically Weaker Section (EWS) in AICTE approved technical institution are considered supernumerary. This means that they are seats over and above the sanction intake, allowing for admission of students from EWS categories without reducing the regular seats.

10. However, the learned counsel for the respondents have stated that as per clause (d), of this Memorandum the institutes were expected to increase the annual permitted strength over a maximum period of two years form the commencement of the Act. Therefore, in 0.A.No.293/2025

the year 2025, the EWS seats cannot be treated as extra seats over and above the approved intake. The Government G.R. has been issued to revise the Staffing Pattern in line with the A.I.C.T.E. guidelines. The Hon'ble High Court of Allahabad in the case of *G.L.Bajaj Institute of Technology and Management Vs. Union of India and Others, 2023 SCC OnLine All 4218 in W.P.No.8770 of 2022* with connected writ petitions decided on 26.04.2023 has already stated that the primacy of A.I.C.T.E. to regulate admission in Technical Institution.

- 11. The applicants in their prayer have raised objection to putting the three categories, namely the (i) students in the Economically Weaker Section (EWS), (ii) Tuition Fee Waiver Scheme (TFWS) and (iii) laterally entered to second year, in the supernumerary category. We examine these three categories in view of the AICTE guidelines (Approval Process Handbook for the years 2024-2027) and reply of the respondents.
- (A) The A.I.C.T.E., guidelines have put the category of Tuition Fee Waiver Scheme (TFWS) students in supernumerary category and therefore cannot be considered in Approved Intake. The relevant clause of the guidelines is given in paragraph 8, above.

(B) The term Lateral Entry is defined in the guidelines as:

Lateral Entry means admission of students into the second year of Diploma/Under graduate Degree courses as per Chapter VII of Approval Process Handbook.

The respondents have accepted in their reply that the category of Lateral Entry students are being considered in approved intake category by them and not as supernumerary. But, in the definition of supernumerary seats given in paragraph 6, the term, "Lateral entry" is included in the supernumerary category. The Clause 6.13 (a) of the Handbook of 2024-2027, "Admission to Lateral Entry to second year course(s)" is as follows:

a. Lateral Entry the second to year Diploma/Undergraduate Degree course(s) as applicable in Annexure-8 shall be permissible up to a maximum of 10% of the "Approved Intake" which shall be over and above, (supernumerary) of the Approved Intake, plus the unfilled vacancies of the First Year as specified in the Approval Process Handbook.

Therefore, the respondents may take an appropriate decision to see that the categorisation of "Lateral Entry" is as per the AICTE guidelines.

- (C) The relevant clauses of the guidelines do not suggest that the category of EWS students is to be treated as supernumerary. The office memorandum dated 17.01.2019 by the Ministry of Human Resource Development, Department of Higher Education, New Delhi is in a different context and cannot be treated as a clarification of the A.I.C.T.E., guidelines for explaining the term Approved Intake. Such clarification, if any, should be mentioned in the AICTE guidelines only. Also, this Notification does not mean that even after two years of the commencement of the Act, the EWS students are to be treated as extra. In fact, this Memorandum suggests that the annual permitted strength has to be increased within the initial two years. Therefore, it is incorrect to treat the EWS students as supernumerary and they need to be included in the category of approved intake only.
- 12. The respondents in their reply filed on 04.04.2025 have also stated that persons affected by the impugned G.R. will be relocated and therefore they cannot be called as persons aggrieved due to this G.R. The scope of this Original Application is limited to examine, if the orders are as per the A.I.C.T.E. guidelines and transfer or relocation of staff, if required, is purely a matter of Government policy.

- 13. The next issue is about the Circular dated 10.02.2025 issued by the Director, Maharashtra State Board of Technical Education. The applicant has stated that this Circular is bad in law. The Teaching/Laboratory hours and other provisions in the Circular are based on A.I.C.T.E. Notification dated 01.03.2019 and the G.R. dated 11.09.2019. The Learned Counsel for the applicant raised some concerns about the quality of teaching if these work hours scheme is implemented. However, the scope of this O.A. is limited to see if the orders by the State Government are in accordance with the A.I.C.T.E. guidelines and not suggesting any modifications or improvements to the guidelines, which are purely in the domain of A.I.C.T.E. The applicants have failed to give any information about how this Circular violates the A.I.C.T.E. guidelines. Therefore, we do not find it necessary to interfere in this matter.
- 14. In view of the above discussion, we pass the following order. The scope of this order is limited to ensuring that the orders passed by the respondents are according to the guidelines of A.I.C.T.E. The impugned orders also mention that these orders have been issued essentially to follow the guidelines of A.I.C.T.E.

ORDER

(i) The O.A. is partly allowed.
