4. Applicants have filed these O.As. contending that they have been regularized as per G.R. dated 11-01-2019 but they were working as Medical Officer Group-B since last more than 10 years but their earlier services before regularization are not regularized.

5. Applicants have pointed out G. R. dated 08-11-2023. It is applicable to Medical Officer Group-A. Learned counsel for applicants pointed out judgment of Maharashtra Administrative Tribunal Mumbai Bench at Nagpur in O.A.No.542/2021 decided on 12-07-2024. Similarly situated Medical Officers were granted relief by directing Health Department to regularize their earlier services from the date of their initial appointment as ad-hoc Medical Officer.

6. It is agreed by the parties that decision whether to regularize the services of the applicants Medical Officers from their initial appointment as an ad-hoc Medical Officer shall be taken by the Secretary, Health Department within a period of 3 months from today and whether their services shall be treated as a regular for the purpose of granting annual increments and earned leave by condoning the breaks. If decision favorable to applicants is not taken by the concerned Secretary, Health Department within 3 months then the applicants will be at liberty to file fresh O.A.

7. Hence, the settlement is arrived at in the above terms. Copy of this settlement shall be sent immediately to the Secretary, Health Department for further action.

8. In view of above, Original Application is settled and disposed of before Lok Adalat.

4. Since in all these matters the issue involved is the same, we have considered all these matters together. Shri T.S.Jadhav, Law Officer of School Education & Sports Department from the office of Deputy Director's Office, Aurangabad is duly authorized for entering compromise/settlement in the present matters. From the facts and documents produced before us, we see substance in the contention raised on behalf of the applicants that, the applicants have raised identical grievance and have claimed the identical relief as was claimed in the O.A.No.720/2023 decided by this Tribunal on 02-11-2023.

5. Learned P.O. representing the Government and the Government representative Shri T.S.Jadhav have not disputed the aforesaid submission. We are informed that, the order passed in O.A.No.720/2023 has attained finality and has been fully complied with by the respondents. Operative order in the said O.A. is reproduced as under:

“(i) Respondents are directed to revise the seniority list published on 21.4.2023 pertaining to the Deputy Education Officers, Maharashtra Education Services, Group-B (Administrative Branch) and place the applicant in the said seniority list at the appropriate place in light of the observations made by us in the body of the present order within 8 weeks from the date of this order.

(ii) The Original Application is allowed in the aforesaid terms without any order as to costs.”

6. Learned P.O. has submitted that in recent past the Joint Director Education (Administration) has forwarded a positive proposal to the Government. In view of the fact that the earlier order has been complied with by the respondents, in view of the G.R. dated 28-02-2017, the same view will have to be taken by the Government.

7. In the circumstances, parties to the proceedings have agreed to settle the matter on following terms:

[i] Respondent no.1 shall consider the proposals of applicants forwarded by the respondent no.3 within three months from the date of this order in view of the decision rendered by this Tribunal in O.A.No.720/2023 on 02-11-2023.

[ii] Needless to state that even thereafter if some dispute subsists the applicants are not precluded from approaching the Tribunal in regard to the said dispute.
