**O R A L O R D E R**

(Per : Justice Shri P.R. Bora, Vice Chairman)

Heard Shri Jitendra V. Patil, learned counsel for the applicant and Shri Mahesh B. Bharaswadkar, learned Chief Presenting Officer for the respondent authorities.

2. The applicant is disabled person and since was given some inconvenient posting he approached this Tribunal by filing the present Original Application.

3. In the present matter on the previous date learned Chief Presenting Officer has produced on record communication dated 05.07.2024 received from the Government to its office. In the said communication the respondents have submitted that the Government is willing to promote the applicant to the post of Head Clerk and to post him in the office of District Superintendent, Land Records, Jalgaon considering that the applicant is unable to undertake everyday travel for attending the office. Learned counsel for the applicant had taken time to

take instructions from the applicant whether the proposal is acceptable to him.

4. Today, when the present matter is taken up for consideration the learned counsel for the applicant submitted that the applicant is accepting the proposal given by the respondents in the communication dated 05.07.2024. Thereupon, learned counsel for the applicant and learned Chief Presenting Officer jointly prayed for disposing of the present Original Application by recording the facts as aforesaid.

5. We have perused the communication dated 05.07.2024. The respondents have resolved to promote the applicant on the post of Head Clerk and to post him at the office of District Superintendent of Land Records, Jalaon. It is further contended that in the annual general transfers of the year 2024, the posting order will be issued in favour of the applicant. In view of the circumstances as above, the following order is passed: -

### **ORDER**

(i) As undertaken in the communication dated 05.07.2024 the respondents shall ensure that order of posting in favour of the applicant on the post of Head

Clerk in the office of District Superintendent of Land Records, Jalgaon is issued in the annual general transfers of the year 2024.

(ii) The Original Application stands allowed in the aforesaid terms, however, without any order as to costs.
