- 2. As the M.A. No. 717/2012, stands allowed by today's order and this O.A. is restored to its original file. Hence, the O.A. is taken up for order on merits.
- 3. Learned Advocate for the Applicant stated that this O.A. has been filed seeking direction to the Respondents to prepare seniority list of the Group "A" posts in the Department of Social Justice at an early date. The same has since been done by the respondents, and the final seniority list has been published on 02.06.2014. Learned

Advocate for the applicant stated that the applicant's prayer for deemed dated of promotion however remains.

- 4. Learned Presenting Officer stated that the applicant has to first make a representation to the respondents about deemed dated of promotion based on the final seniority list. At present, this prayer is premature.
- 5. It appears from amended Clause-D of the Prayer Clause, that representation regarding deemed date of promotion has been submitted by the applicant to the Respondents. However, if that representation was made before the finalization of the seniority list, it may not be help the applicant at this stage. The applicant therefore, if he so desires, may make a fresh representation based on final seniority list for deemed date of promotion. In case the said representation is filed by the applicant within one month from the date of this order, the respondents shall take decision on the same within a further period of three months and communicate the decision taken the on representation to the applicant in writing.
- 5. With these observations and directions, the O.A. stands disposed of with no order as to costs.
