- 2. Present Original Application proceeds on following admitted facts:-
- (i) Applicant was a Government servant.
- (ii) By virtue of transfer of certain functions of the Government to Zilla Parishad, applicant's services being held in relation to those functions, where allocated to Zilla Parishad, Thane.

(iii) The day on which the orders of permanent absorption were

issued, the applicant was under suspension.

3. Now the applicant's plea is that by virtue of Government

decision dated 20.4.2013, since applicant is under suspension, he

ought not be posted or transferred to Zilla Parishad. (Copy of

Government decision dated 20.4.2013 is at Exh. H, page 27).

4. Perused the same. It relates to matters of administration of

Government servants.

5. Applicant has ceased to be a Government servant. Moreover,

it is not a case of posting after revocation of suspension.

6. Applicant shall stand permanently allotted to Zilla Parishad,

subject to continued suspension and departmental enquiry.

7. Applicant shall be dealt with in accordance with law.

8. Applicant is however, not entitled to any relief whatsoever.

9. Interim relief stands vacated.
