Applicant and his advocate absent. Heard Mrs K.S Gaikwad, learned Presenting Officer for Respondent no 1 & 2 and Shri G.A Bandiwadekar, learned advocate for Respondent no. 3.

We have perused our order of 18.2.2016 and the earlier order dated 17.11.2005. Mrs K.S. Gaikwad has since ascertained the position with regard to the W.Ps to which reference was made in the order of 17.11.2005.
