## ORDER

- 1. Heard Shri N.P Dalvi, learned advocate for the Applicant and Ms Archana B.K. learned Presenting Officer for the Respondent.
- 2. The Applicant has filed this Original Application seeking that his representation dated 20.6.2016 for giving him a posting of his choice as per G.R dated 6.8.2002 may be considered. The Applicant has cited two reasons for making this request, (i) he has been posted to Gadchiroli District which is a Naxalite Affected area for last four years and as per G.R dated 6.8.2002 a person who has worked in Naxalite affected area can be considered for giving a posting in one of three district of his choice, and (ii) he is retiring within a period of 10 months and as per Government policy during his last year of posting he can be posted as per his own choice and that he may be posted in his Home district.
- 3. Learned Advocate Shri Dalvi stated that he is seeking limited relief that Respondent may be directed to consider representation dated 20.6.2016 in the light of aforesaid mentioned G.R dated 6.8.2002.
- 4. Learned Presenting Officer (P.O) stated that the Applicant's request was already considered and it has been rejected. She, however, admitted that the Applicant

has not been informed that his representation has been rejected. She stated that the Applicant will be informed accordingly.

5. It appears that the Applicant has filed various representations. The representation dated 1.6.2016 apparently has been rejected. However, another representation dated 20.6.2016 has still not been

considered by the Respondent.

6. This Original Application is disposed of accordingly with direction to the Respondent to consider the representation of the Applicant dated 20.6.2016 in the light of the G.R dated 6.8.2002 and any other G.R regarding giving posting to a Government servant in his Home district during the last year of his service. This may be done within four weeks from the date of this order. No order as to costs.
