JUDGMENT

Heard Shri G.G. Bade, learned counsel for the applicant and Shri A.P. Potnis, learned P.O. for the respondents.

2. The applicant is working as a Circle Officer at Gondia. The applicant requested for inter district transfer / requesting to transfer him at Nanded. Respondents have not considered his request and therefore, the applicant approached to this Tribunal for the following reliefs –

- " (9) (i) quash and set aside the letter dated 24/03/2023 issued by the respondent no.3 and thereby direct the respondent no.3 to absorb the applicant as Circle Officer, in Nanded District, in the interest of justice.
- (10) The applicant is seeking stay to the effect and implementation of order dated 24/03/2023 issued by the respondent no.3, during the pendency of the present original application, by directing respondent no.3 to reconsider the request of the applicant."
- 3. The O.A. is strongly opposed by the respondents. It is submitted that no post is vacant at Nanded, therefore, the applicant cannot be transferred on his own request. Hence, the O.A. is liable to be dismissed.
- 4. During the course of submission, the learned counsel for applicant has pointed out the G.R. dated 15/05/2019 and submitted that as per this G.R., the applicant is entitled to get inter-district transfer.
- As per the submission of learned counsel for applicant, the Appointing Authority at Gondia had given NOC to transfer him from Gondia to Nanded, but the Appointing Authority at Nanded not given any such Certificate and therefore he is not transferred to Nanded.
- 6. The conditions in the said G.R. are very clear that interdistrict transfer cannot be claimed as of right. The post where he wants inter-district transfer should be vacant. As per Clause 8 (1), (2)

& (3) of the G.R. dated 15/09/2019, the following conditions are to be fulfilled –

		केली असेल तर संबंधित जिल्हयातील "कर सहायक" संवर्गातील सरळसेवा
		कोटयातील रिक्त पदावरच कायमस्वरुपी समावेशन अनुज्ञेय राहील.

As per Clause no.8 (3) for inter-district transfer, the post where he wants the transfer shall be vacant and the Appointing Authority at the transferred place shall give NOC to accommodate him at the request transfer place. As per the submission of respondents,

O.A. No. 798 of 2023

no post is vacant at Nanded and therefore the applicant cannot be

transferred on his own request.

8. The learned counsel for applicant has pointed out the

Judgment of this Tribunal in O.A.No.49/2023. This Judgment is not

applicable in view of the G.R. dated 15/05/2019. The condition for

inter-district transfer is not fulfilled, no post is vacant at Nanded. The

Appointing Authority at Nanded has not given any NOC, therefore, the

Government has not considered the request of the applicant for inter-

district transfer from Gondia to Nanded. There is no illegality on the

part of the respondents. Hence, the following order -

ORDER

(i) The O.A. is dismissed.

(ii) No order as to costs.
