2. Heard Smt. Punam Mahajan, the learned Advocate for the Applicant and Smt. K.S. Gaikwad, the learned Presenting Officer for the Respondents.

3. The Applicant is working as an Executive Engineer. He has been making representations for proper placement in the seniority list in V.J. - A category. This O.A. relates to two such representations dated 8.2.2016 and 16.2.2016.

4. The Applicant wants them to decide representations within two weeks. The affidavit-in-reply has not been filed. I may again refer to my order dated 31.3.2016.

5. Learned P.O. for the Respondents upon instruction from Shri S.N. Pore, Desk Officer, P.W.D. made submissions at the bar. Learned Advocate for the Applicant Smt. Mahajan supported her case.

6. In my opinion there is no point in protracting this O.A. regard being had to the ambit and the ultimate scope hereof. Although the learned Advocate for the Applicant

seeks directions that till the decision of the representations in question the promotion to the post of Superintendent Engineer be held in abeyance. I do not think such directions can to be given going by the relief herein sought. As far as the outer time limit to be fixed. Learned Advocate for the Applicant and learned P.O. for the Respondents remain faithfully adhered to their respective briefs. One is seeking time as short as two weeks and the other as long as infinity.

7. In my view time of two months will have to be granted which would subserve the interest of both the sides.

8. This O.A. is disposed of with directions that the representations dated 8.2.2016 and 16.2.2016 made by the Applicant be finally decided within two months from today and the result thereof be communicated within one weeks thereof to the Applicant. Needless to say that the right of the Applicant to take recourse to the legal remedies if he is still left aggrieved is kept intact.
