JUDGMENT

(Delivered on this 2nd day of September,2024)

Heard Shri R.V. Shiralkar, learned counsel for the applicants and Shri A.M. Khadatkar, learned P.O. for the respondents.

- 2. Grievance of the applicants is that though they are entitled to get encouragement allowance for the period during which they had served in naxal / tribal area of Pandharkawada, Dist. Yavatmal, they have been unjustly deprived of the same. Hence, this O.A.
- 3. In support of their claim, the applicants have relied on G.R. dated 09/03/1990 (Annex-A-2), G.R. dated 05/02/1999 (Annex-A-3) and G.R. dated 06/08/2002 (Annex-A-4). As per G.R. dated 09/03/1990 Pandharkawada is designated tribal area. G.R. dated 05/02/1999 specifies the rates at which encouragement allowance is to be paid. Internal page-4 of G.R. dated 06/08/2002 refers to G.R. dated 05/02/1999 and the rates stipulated therein at which encouragement allowance is to be paid.

4. The applicants have also relied on G.R. dated 09/11/2005 (Annex-A-5) which supplies clarification in respect of payment of encouragement allowance. This G.R. states –

- ३. सदर प्रकल्प क्षेत्र वाढीव प्रोत्सा□न भत्त्यासाठी अतिसंवेदनशील म्हणून ग्रा□य धरण्यात यावीत. या ११ एकात्मिक आदिवासी प्रकल्प क्षेत्रातील जी गांवे / श□रे संदर्भाधीन दि.९ मार्च, १९९० च्या शासन निर्णयान्वये घोषित केलेल्या आदिवासी उपयोजना क्षेत्रामध्ये समाविष्ट आं तत्या गावात/श्र□रात प्रत्यक्ष कार्यरत असलेल्या व मुख्यालय असलेल्या अधिकारी/कर्मचाऱ्यांच्या बाबतीत त्यांच्या मूळ वेतनाच्या १५% इतका किमान रु.२००/- व कमाल रु.१५००/- दरमण या मर्यादेत प्रोत्सा□न भत्ता अनुज्ञेय रां तिल. सर्वसाधारण आदिवासी क्षेत्रात काम करणाऱ्या

- 5. It may be mentioned that G.Rs. dated 09/03/1990, 05/02/1999 and 09/11/2005 are issued by Tribal Development Department whereas G.R. dated 06/08/2002 is issued by GAD of Government of Maharashtra.
- 6. Stand of respondent nos.5 and 6 is as follows –

The G.Rs. relied upon by the applicants were issued when salary and allowances were being paid as per 5th Pay Commission. Therefore, encouragement allowance is being paid since then on the basic pay fixed by the 5th Pay Commission as no revised G.Rs. have been issued to pay encouragement allowance on the basis of basic pay fixed as per the 6th and the 7th pay commissions.

- 7. There are two communications dated 17/06/2020 (Annex-A-13) and 25/06/2020 (Annex-A-14) issued by Village Development Department of Government of Maharashtra which states that encouragement allowance is to be calculated on the basis of pay commission which is made applicable and the amount of such allowance shall not be less than Rs.200/- and it shall not exceed Rs. 1500/-.
- 8. G.R. dated 06/08/2002 lays down

From the aforequoted portion conclusion is inescapable that

quantum of encouragement allowance is to be determined on the basis of

basic pay drawn by the employee at the relevant point of time, subject to

minimum of Rs.200 and maximum of Rs.1500. It is , therefore, held that

amount of encouragement allowance is to be calculated on the basis of

basic pay drawn by the employee at the relevant point of time. The

respondents shall accordingly consider case of each of the applicants and

pay encouragement allowance as per determination made hereinabove on

being satisfied that they are entitled to get it subject to minimum of Rs.200

and maximum of Rs.1500, as per G.R. dated 06/08/2002. Arrears to be

calculated on the basis of this determination shall be paid within three

months from today. The O.A. is allowed in these terms with no order as to

costs.
