**J U D G M E N T**

1. Heard Party in person and Shri N.K. Rajpurohit, the learned Presenting Officer for Respondent No.1.
2. None has appeared for Respondent No.2.
3. Applicant's prayer (a) and (b) reads as follows :-
  - “(a) This Hon'ble Tribunal be pleased to hold and declare that the impugned order dated 7<sup>th</sup> June, 2017 as illegal and bad in law and the same to be quashed and set aside.
  - (b) This Hon'ble Tribunal be pleased to pass an order directing respondent no.1, the Govt. to transfer and / or post the Applicant at Grant Govt. Medical College, Mumbai.”

4. Oral and written submissions and averments in the Original Application do not reveal any illegality which may or be the foundation of first prayer (a).
5. In so far as Prayer (b) is concerned, it cannot be held that the Government is not conscious or alive towards applicant's claim.
6. Applicant's request for posting craved by him may still be under consideration. There is nothing on record to show that applicant's request for posting according to his request is rejected. Moreover, a Government servant cannot claim as a matter of right for any particular posting.
7. Applicant does not have enforceable legal right to claim a particular posting or transfer. Since applicant's claim is based on his expectations and not on legal right, hence any direction cannot be issued.
8. Hence, Original Application is disposed. There shall be no order as to costs.
