Heard Mr. K.R. Jagdale, the learned Advocate for the Applicants and Mrs. K.S. Gaikwad, P.O. holding for Mr. N.K. Rajpurchit, the learned Chief Presenting Officer for the Respondents.

This OA seeks alternative reliefs and Mr. Jagdale, the learned Advocate for the Applicant restricted the claim herein to the alternative relief and deciding the representation of the Applicant dated 15.5.2014. The first alternative relief is not being pressed in this OA now. Liberty is reserved for them to do so, if circumstances so warrant and bring any other appropriate action on the same cause of action.

Notice was issued to the learned Advocate General because there was a challenge to a certain Government instrument. Mr. Jagdale told me that in view of the fact that he is restricting his relief only to the alternative prayer, that aspect of the matter no more remains at large. As far as the submission of the learned CPO made on the last occasion that this is a Division Bench matter, I find that in view of the prayer having been restricted to the alternative prayer only if a Single Bench can make an appropriate order.

The matter has been kept back for the learned CPO to appear. However, I do not think, I should wait any longer. Mrs. Gaikwad, the learned PO holds for the learned CPO.

In view of the foregoing, this OA is disposed of with a direction to the Respondent No.2 to consider and decide the representation of the Applicant dated 15.5.2014 within six weeks from today and communicaste the decision to the Applicant within one week thereafter. As already mentioned above, all rights and contentions are kept open. No order as to costs.
