ORDER

- 1. Heard Shri C.T. Chandratre, learned Advocate for the Applicant, Shri A.J. Chougule, learned Presenting Officer for the Respondent No.1, Shri A.V. Bandiwadekar, the learned Advocate for the Respondent No.2. None for the Respondent No.3.
- 2. This Original Application has been filed by the Applicant challenging the order dated 5.6.2015 issued by the Respondent No.1 and he is seeking restoration of order dated 30.5.2015.
- 3. Learned Counsel for the Applicant argued that the Applicant was transferred from Sangamner, Dist. Ahmednagar to Loni Kalbhor, Dist. Pune by order dated 30.5.2015, issued by the Respondent No.1 in place of the Respondent No.2. The Respondent No.2 filed O.A. No.413 of 2015 before this Tribunal and by order dated 4.6.2015 this Tribunal stayed the transfer of the Respondent No.2 to Velapur, Dist. Solapur. As a result, the Applicant could not join at Loni- Kalbhore, Dist. Pune and his transfer is also

effectively stayed. Learned Counsel for the Applicant contended that he was transferred on request to Pune. He is a Group 'C' person, and has completed 5 years in Ahmednagar District. One of the reasons for staying order dated 30.5.2015 was that the present Respondent No.2 had not completed her tenure of six years in Pune District. Now, during the general transfers of 2016, she would have completed her tenure and the Applicant may be considered for transfer to Pune District in place of the Respondent No.2 who has been in Pune for total of 5 years considering her earlier tenures.

- 4. Learned P.O. for the Respondents argued that the transfer order dated 30.5.2015 has been stayed by this Tribunal by order dated 4.6.2015 in O.A.No.413 of 2015. The order dated 5.6.2015 has been issued to implement the order of this Tribunal dated 4.6.2015. Learned P.O. argued that the Applicant is not entitled to any relief.
- 5. Learned Advocate Shri A.V. Bandiwadekar stated that the Respondent No.2 was posted to Pune district in 2010 but she would not complete two tenures of 3 years each on 31.5.2016. She is, therefore, not due for transfer in the ensuig general transfers.
- 6. It is seen that the Applicant has challenged the order dated 5.6.2015 issued by the Respondent No.1. This order has been issued pursuant to the order issued by this Tribunal in O.A.No.413 of 2015 filed by the Present

Respondent No.2. As the transfer of the present Respondent No.2 from Pune to Solapur District was stayed by this Tribunal, the Applicant could not be transferred to Pune in the place of the Respondent No.2. The request of the Applicant to declare the order dated 5.6.2015 as illegal can not be granted. Similarly, the prayer to implement order dated 30.5.2015 can not be granted unless the stay order in O.A.No.413 of 2015 is vacated or that O.A. is finally disposed

7. It is however, clarified that if the present
