Heard Shri D.D. Ahire, learned Advocate for the Applicant and Shri N.K. Rajpurohit, learned Chief Presenting Officer for the Respondents.

- This OA seeks to challenge the order dated 3.9.2015 whereby the applicant a Forest Labourer came to be terminated because of the alleged non fulfillment of the required work of 240 days per year for 5 years.
- The applicant and 37 others came to be absorbed by order dated 6.12.2012 as Forest Labourers. Then about 3 years there afterwards by the impugned order, the applicant was terminated which is why he is up before us in this OA.
- We have perused the record and proceedings. In fact on a very short point which however, is of vital significance this OA has to be disposed off with necessary directions. It so happened that except for a show cause notice no other steps were taken. The DE was not held. This lapse is not just a pointless nitpicking. It is of momentous significance. It so happened that the very nature of allegations were such as to be explained away by the applicant which may not necessarily be only by way of response to the show cause notice. Therefore, unless full deportunity was given to the applicant to know the rature of accusations against him and then an avenue to defend him the principles of natural justice would not have been followed and complied with and such order cannot be sustained even in the

circumscribed jurisdiction of judicial review of administrative action. The process of reaching the conclusion was surely vitiated in an irredeemable manner and, therefore, interference is called for.

- In so far as the question of immediate reinstatement is concerned as of today we are not so inclined as to order immediate reinstatement. However, if the respondents were to fail to keep the deadline to be set by us within which the DE should be concluded then even as the DE might continue but the applicant will have to be reinstated.
- The impugned order stands hereby quashed The matter is remitted to the and set aside. respondent no.1 for holding regular departmental enquiry against the applicant in accordance with the rules relevant and to conclude the same by issuance of an order and communication thereof to the applicant within four months from today. In the event of his failure to do so, even as the DE may continue but the applicant will have to be reinstated as Forest Labourer the post from which he came to be terminated. OA is disposed off in these terms with no order as to costs.
