ORDER

1. Heard Shri Shri A.V Bandiwadekar, learned advocate for the Applicant, Shri A.J Chougule, learned



Presenting Officer for the Respondents and Shri D.B. Khaire, learned Special Counsel for Respondents no 3 & 4.

- 2. This Original Application has been filed by the Applicant, seeking implementation of the order of transfer dated 31.5.2015 posting her at Sassoon Hospital, Pune. Though Sasson Hospital, Pune is controlled by the Respondent nos 3 & 4, there are posts which are on the establishment of the Respondent nos 1 & 2. The Respondent no. 2 was well within his powers to post the Applicant in the vacant post of Medical Officer at Sasson Hospital, Pune.
- 3. Learned Special Counsel Shri D.B Khaire argued on behalf of the Respondent nos 3 & 4 that this issue has already been decided by this Tribunal by order dated 23.12.2015 in O.A no 792 of 2015. In that Original Application also, many Applicants on the establishment of Public Health Department, who were transferred by the same order dated 31.5.2015 by the Respondent no. 2 to the posts in the hospitals under the control of the Respondents no 3 & 4 had sought similar reliefs. This Tribunal has dismissed the aforesaid Original Application no. 792 of 2015 on the ground that order dated 31.5.2015 was issued in contravention of a Cabinet decision. Learned Special Counsel argued that this

Original Application may also be dismissed on the same ground.

- 4. It is seen that no affidavit in reply has been filed in the present Original Application on behalf of the Respondents no 1 & 2. The position of the Respondent nos 3 & 4 is that a Cabinet decision has already been taken to convert posts in the hospitals under their control, which were on the establishment of Public Health Department to cater to the need of new departments which are proposed to be created in Medical Colleges. As such, there are no vacancies in which the persons like the present Applicant can be accommodated. This issue has already been decided by this Tribunal by order dated 23.12.2015 in O.A no 792 of 2015. This Tribunal has already refused to intervene in the matter of implementation of transfer order dated 31.5.2015.
- 5. This Original Application is, therefore, dismissed with no order as to costs.
