Heard Shri A.V Bandiwadekar, learned advocate for the applicant and Shri K.B. Bhise, learned Presenting Officer for the Respondents 1 & 2.

The final seniority list of 10.2.2016 issued by the Divisional Commissioner, Konkan Division, Navi Mumbai, is taken on record. Shri Bandiwadekar submits that the Applicants are satisfied with their placement in the said seniority list and therefore, they do not want to continue to prosecute this O.A and wanto to withdraw the same with a request that necessary direction be given to the Respondents no 1 & 2 with regard to grant of deemed date of promotion and the same be disposed of within a time frame.

Learned P.O in effect submits that no specific time frame be fixed for considering the representation for grant of deemed date of promotion.

In view of the above, O.A is allowed to be withdrawn and is as such disposed of as not pressed with no order as to costs. It is directed that if the Applicants make an application for grant of deemed date of promotion within one week from today, the Respondents no 1 & 2 shall decide the same as expeditiously as possible preferably within a period of four months from the date of receipt of the representation and communicate the decision thereon to the Applicants.
