JUDGEMENT

Heard Shri G.G.Bade, ld. counsel for the applicant and Shri A.M.Khadatkar, ld. P.O. for the Respondents 1 to 3. None for the R-4.

2. Case of the applicant in short is as under:-

The applicant was appointed as a Block Development Officer as per order dated 09.06.2014. Thereafter applicant was promoted as Deputy Chief Executive Officer, Group-A as per order dated 24.05.2022. The applicant was posted as Deputy Chief Executive Officer, Z.P., Buldhana. In view of the General Election the applicant is appointed as Sector Officer (P. 33). The respondents have not followed guidelines of Election Commission of India and he is transferred to Pusad, therefore, approached to this Tribunal for following relief:-

i) Quash and set aside the impugned transfer order dated 25.09.2024 (A-1) issued by the respondent no. 1.

ii) Grant any other relief, which this Hon'ble Tribunal deems fit and proper in the facts and circumstances of the case so also, in the interest of justice.

3. It is submitted by ld. P.O. that applicant is working in Buldhana since 2016. The Civil Services Board has recommended the transfer and, therefore, applicant is transferred. Hence, the O.A. is liable to be dismissed.

4. Applicant has filed rejoinder and submitted that one officer namely Dnyaneshwar Takras is deputed in place of the applicant in Pusad therefore, impugned order is liable to be quashed and set aside.

5. During the course of submission, ld. counsel for the applicant has submitted that in view of the guidelines issued by the Election Commission of India dated 31.07.2024, the Sector Officer/ Zonal Magistrate involved in the Election Duty are not covered under the Clause – III of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005. As per his submission, applicant is appointed as Sector Officer, therefore, transferring the applicant is not legal and proper, therefore, prayed to quash the impugned transfer order.

6. Ld. P.O. has pointed out recommendation of Civil Services Board. It is filed along with the reply. As per the recommendation of Civil Services Board he is working in Buldhana from the year 2016. He was due for transfer. The applicant is transferred on the post of Block Development Officer, Pusad. The ld. P.O. has submitted that applicant was transferred as per the recommendation of Civil Services Board. Hence, O.A. is liable to be dismissed.

7. There is no dispute that applicant is working at Buldhana since 2016. Applicant was due for transfer. The Civil Services Board

has taken into consideration engagement in Election Duty. Recommendation of Civil Services Board is reproduced below:-

8. The Government has decided to transfer the applicant. It is for the government to conduct the Election fairly and smoothly as per Clause - III of the guideline issued by the Election Commission of India. The employee who has completed three years of period or having Home District shall be transferred. Hence, the applicant was due for transfer his name was recommended for transfer by the Civil Services Board. It is also mentioned in the recommendation that as per direction of the Government he be transferred and posted as a Block Development Officer. Hence, the impugned transfer order is perfectly legal and correct. Hence, O.A. is dismissed with no order as to costs.
